CHED MEMORANDUM ORDER Series of 1996

SUBJECT

HIGHER DEVELOPMENT FUND (HEDF) TO THE STATE COLLEGES (SCS) LISTED IN THE BODY OF THIS ORDER FOR INSTITUTIONAL SUPPORT, UPGRADING AND/OR DEVELOPMENT INCLUDING, BUT NOT LIMITED TO, IMPROVING LIBRARY FACILITIES AND UPDATING AND/OR LABORATORY EQUIPMENT, AND SETTING THE REQUIREM AND/OR CONDITIONS THEREFOR

In accordance with the pertinent provisions of Republic Act No. 7722. otherwise known as the "Higher Education Act of 1994," and in view of the operationalization of the Higher Education Development Fund (HEDF) created by virtue of the same law, the following State Colleges (SCs) may avail of a grant from the HEDF for institutional support, development and/or upgrading, including, but not limited to, improving their library facilities and buying and/or updating laboratory equipment, namely :

Bataan State College (Dinalupihan, Bataan) Ramon Magsaysay Polytechnic College (lba, Zambales)

Siquijor State College (Larena, Siguijor) Region VIII

Southern Leyte \$tate College of Science and Technology (Sogod, Southern Leyte)

Region X Camiguin Polytechnic State College (Province of Camiguin) Region XI

Davao del Norte State College (Panabo, Davao del Norte) Region XIII

> Agusan del Sur State College of Agriculture and Technology (Bunawan, Agusan del Sur)

In order for the aforerhentioned SCs to avail of the grant herein established. the following conditions and for requirements must be met, to wit :

- A written proposal signed by the President of the SC concerned specifying therein the project, the cost and such other details that may help facilitate and expedite approval by the Commission of the requested grant;
- A resolution of the SC's Board of Trustees concurring to the proposal and requesting approval of the same by the Commission, duly authenticated by the Board Secretary and attested by the Presiding Officer:
- Both of the above should be submitted to the Commission (Attention : HEDF Secretariat);
- Upon receipt thereof by the HEDF Secretariat, it shall study, analyze and verify the same and then submit its recommendations to the Commission en banc within ten (10) days from date of receipt;
 - The Commission may approve or reject the proposal or may suggest revisions thereof:
 - In case the proposal is approved by the Commission, the grant shall be caused to be released by the HEDF Secretariat within fifteen (15) days from the date of approval by the Commission;
 - In case the proposal is disapproved by the Commission, the SC concerned may present it again but with revisions duly made.

This Order shall take effect immediately and shall remain in force and effect until revoked.
