SUBJECT

1996 National Search for the Ten Outstanding Students of the Philippines (TOSP) sponsored by the Commission on Higher Education in collaboration with the RFM Foundation, Inc., the RFM Group of Companies and the Rotary Club of Makati Central

In accordance with the pertinent provisions of Republic Act (R.A.) No. 7722, otherwise known as the "Higher Education Act of 1994" and by wirtue of Resolution No. 001, series of 1995, of the Commission on bane, all Regional Directors, Chiefs of the Commission on Higher Education, Presidents of State Colleges and Universities and Heads of Private Schook, Colleges and Universities are hereby directed, thus:

As a member of the TOSP Executive Committee, the CHED calls on all government and private tertiary level educational institutions to actively encourage the participation of all top graduating students and to nominate their top students under each field of specialization to the above National Secretariat not later than Aral 15, 1996.
