SUBJECT

AMENDING CHED, ORDER NO. 105. ENTITLED "AMENDED ALLOCATION OF FINANCIAL BENEFITS TO AWARDEES SCHOLARSHIPS AND STUDY GRANT PROGRAMS" BY ELIMINATING THE CEILING ON THE AMOUNT WHICH HIGHER EDUCATION INSTITUTIONS (HEIS) COULD BILL FOR TUITION AND OTHER FEES FOR THE NATIONAL INTEGRATION STUDY GRANT PROGRAM (NISGP) AND THE SELECTED ETHNIC GROUP FOUCATIONAL ASSISTANCE PROGRAM (SEGEAP)

In accordance with the pertinent provisions of Republic Act No. 7722, otherwise known as the "Higher Education Act of 1994," and of existing laws, rules and regulations, and in view of differing budgets for the various scholarship programs of the government, it is hereby ordered, thus:

- Henceforth, the benefits of awardees of the National Integration Study Grant Program (NISGP) and the Solected Ethnic Group Educational Assistance Program (SEGEAP) shall be the following, namely:
 - Tuition and other fees per semester as actually billed by the Higher Education Institution (FIEI) concerned;
 - b. Stipend of Two Thousand Pesos (P2,000.00) per semester; and
 - Book allowance of Two Hundred Fifty Pesos (P250.00) per semester
- As to awardees of the National Reconciliation and Development Program (NRDP), they shall likewise enjoy the aforemetricines: benefits except that the tuition and other fees which could be billed by the HEI concerned shall be up to Two Thousand Seven Hundred Fifty Pesos (P2,750.00) only per semester.

- The aforementioned benefits shall be deemed automatically forfeited in the event the awardee avails of other government scholarships and/or study grants and/or the like.
- The availment of the said benefits shall be terminated for non-availability and/or exhaustion of funds.
- This CHED Memorandum Order (CMO) shall amend, supersede and/or revoke all previous issuances or any of its provisions on the same subject matter which may be contrary to or in conflict herewith.
