1997 Regional Sarach for the Ten Outstanding Students of the Philipprines (TOSP) sponsored by the Commission on Higher Education in collaboration with the RFM Foundation, Inc., Rotary Club of Makati Central, RFM Group of Companies and National Book Store, Inc.

In accordance with the pertinent provisions of Republic Act (R.A.) No. 7722, otherwise known as the "Higher Education Act of 1994" and by urture of Resolution No. OOI, series of 1995, of the Commission en banc, all Regional Directors, Commission on Higher Education, Presidents of State Colleges and Universities and Heads of Private Schools, Colleves and Universities are hereby directed, thus:

- The subject undertaking is hereby officially endorsed by the Commission for the support and participation of all concerned;
- 2. The Ten Outstanding Students of the Philippines (TOSP) Award is a youth-tecognition project which seeks to select and award the nation's outstanding graduating college students as they enter their respective professions. It highlights the importance of achievement and excellence in academics, of fostering leadership qualities and of cultivating a deep sense of social responsibility among college students;
- In 1994, TOSP embarked on a regional search so that students in the regions can closely identify themselves with the role models selected form their immediate environment. To date, it has regional searches in Regional LII, V. JVIII, X. XI and the Gordillera Administrative Region . Regional winners become their entry to the national search.

- All private and public higher education institutions are encouraged to participate and be actively involved in this undertaking. For the regional search, educational institutions are requested to coordinate with any of the following Regional ToSP Secretariates.

The schools are enjoined to create, as much as possible, their own School Level Selection Committee in screening their candidates/nominees for the national search for submission to the President of the school who shall then endorse the school's candidates to the above addresses or to the following:
 - a. CHED Regional Offices
 - b. Any branch office of the RFM Group of Companies, i.e. Swift Foods, Inc.-Agri- Business Division, Swift Foods, Inc. - Meat Division, COSMOS Bottling Corp. or Selecta Dairy Foods, Inc.
- 7. As a members of the TOSP Executive Committee, CHED calls on all government and private tertiary level educational institutions to actively encourage the participation of all top graduating students under each field of specialization to the National TOSP Secretariat not later than April 15, 1997.
