International Conference on Access to Higher Education to be held at the Manila Hotel, One Rizal Park 1099, Manila on 23-24 March 2004

The Commission on Higher Education is holding the 1<sup>st</sup> International Conference on Access to Higher Education with the theme "Access to Higher Education: Redefined" on 23-24 March, 2004 at the Fiesta Pavilion, Manila Hotel, One Rizal Park 1099, Manila.

The international conference aims to provide a venue to discuss access and equity in higher education in the 21<sup>st</sup> century. Specifically, the conference shall:

- Identify regional and national trends and strategies on access to higher education system in keeping with article 26-1 of the Universal Declaration of Human Rights.
- Define and pursue systems to broaden access to higher education.
- Discuss significant progress to achieve access of women, various socio-economic, cultural and political groupings to higher education in the implementation of accessible higher education for all sectors (women, indicenous, poor, disabled, etc.)
- Develop and resolve to adopt a declaration on global strategies to redefine access.

All Heads of Higher Education Institutions (HEIs), directors of admissions, researchers and deans are hereby enjoined to participate.

The participants who pre-register/pay on or before February 27, 2004 shall be charged a registration fee of Two Thousand Five Hundred Pesos (P2,500.00).

For late registrants starting February 28, 2003 registration fee is Three Thousand Pesos (P3,000.00). The registration fee covers meals, kits and conference materials.
