The Commission on Higher education (CHED) through the Office of Policy, Planning, Research and Information will hold a series of Zonal/Regional Consultation Conferences (Z/RCCs) this year on the Medium-Term Development Plan for Higher Education (MTDPHE) 2005-2010. The Z/RCCs will be held in Regions III, VII, XI and NCR starting March 29, 2005 with active involvement of selected participants representing various stakeholders of higher education from the various regions of the country.

The objectives of the consultation conference are:

- 1. To elicit comments and feedback on the draft MTDPHE;
- To ensure that the regional development priorities and manpower needs along with the sectoral concerns of higher education stakeholders are reflected in the plan
- 3. To validate the data/information presented in the plan
- To finetune the proposed policies, strategies and programs/projects to support the development of higher education in the country.
