SUBJECT: GUIDELINES FOR THE SEARCH FOR BEST HEI RESEARCH PROGRAMS

In consonance with Section 8 of Republic Act (R.A.) No. 7722, mandating the Commission on Higher Education (CHED) to enhance the research function of higher education institutions (HEIs) in the Philippines, and pursuant to CEB Resolution No. 638 of 2005, CHED hereby issues the Guidelines for the Search for Best HEI Research Programs, for immediate dissemination.

GUIDELINES FOR THE CHED BEST HEI RESEARCH PROGRAMS

A. Purpose

Research as one of the triad functions of higher education institutions (HEIs) enhances the individual's capacity to conduct technology-directed and innovative/creative work. Since colleges and universities are among the primary institutions tasked to generate and disseminate knowledge, they should be encouraged to conduct research and other scholarly investigations in the various academic disciplines. Higher education institutions play an important role in developing and nutruring a "research culture" among the people.

The CHED Best Research Program is intended to recognize both the author(s) - implementors and the HEI for the research program that has contributed most to the cluster of discipline(s).

B. The Awards

National Winner -

- Trophy
- P 1M cash award

Regional Winners -

- Plagues of recognition
- P300,000 cash award for 1st prize
- P200,000 cash award for 1st runner up
- P100,000 cash award for 2nd runner up

C. Scope

The award is open to all HEIs in the country, public and private. The candidate research programs (two at the most per HEI) should be:

- · active with breakthroughs/accomplishments outputs during the last 5 years
- · essentially applied and
- multi-disciplinary

D. Criteria

 Development impact – refers to the contribution of the program to national development and productivity of the society based on the technologies developed (new product, equipment, gadget, methods & processes, etc.) and economic and social benefits derived from the program 40%

2. Impact on the discipline — refers to the contribution of the program to science & technology, patents; the improvement of academic programs such as new courses instituted/courses revised; better and innovative ways of teaching; improved student performance; better teaching materials; new knowledge/theory obtained from the research program; revision of old ideas to the new knowledge from the program; publications published within 5 years (refereed journal articles, books/chapters,

monographs and other types); and papers presented in scientific conferences, seminars and other forums.

3. Institutional and policy environment for the Program— refers to the organizational/infrastructural and the policy support provided by the HEI as evidenced by the certified list of the support provided by the HEI to the research program, such as but not limited to: research center/office, equipment, amount of funds, manpower, publication support and policies supportive of research.

4. Novelty or originality — as shown in the state of the art review

 Recognition given to the program - refers to citations, awards given by awarding organizations/bodies based on photocopies of certificates and other mementos of the awards/citations and other forms of recognition from external organizations and scientific societies (here and otherset).

E. Nomination & Selection Procedure

Each nomination should be signed by the President of the concerned institution and submitted to CHED-OPPRI or Regional Offices. Entries shall be evaluated by the CHED Awards Board with the following composition:

Program Committee for comments. It was noted that the award scheme now includes Regional winners: 1 first prize, 1 first runner up and 1 second runner up. Regional winners shall receive a plaque of recognition; cash awards of P300,000 for the 1st prize, P200,000 for 1st runner up & P100,000 for 2nd runner up. However, this shall entail an additional P9,000,000.00 to its budget.

Commissioner Defensor reiterated that the award should be distributed equitably to avoid giving the awards to only a few selected institutions.

The Commission further tasked the OPPRI Director to conceptualize another research award for average performing HEIs.

Upon motion duly made, seconded, and unanimously carried, the following resolution was adopted by the Commission en banc, thus:
